WHEREAS, we, Sally F. Parrott and W. Howard Fowler

with interest thereon from **date** at the rate of **12%** per centum per annum, to be paid: **In full at maturity.**

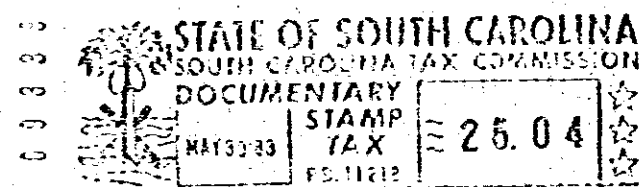

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, the Mortgagee's heirs, successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, located on Byrd Boulevard and designated as Lot No. 161 on Plat of second revision of Traxler Park recorded in the RMC Office for Greenville County, South Carolina in Plat Book F at pages 114-115, and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin at the corner of Lot No. 100 on Byrd Boulevard and running thence with Byrd Boulevard, S. 80-21 E. 75 feet to an iron pin at the corner of Lot No. 160; thence S. 14-44 W. 182.7 feet to an iron pin at the corner of Lot No. 101; thence N. 52-56 W. 75 feet to an iron pin at the corner of Lot No. 100; thence N. 12-34 E. 147.6 feet to the beginning corner on Byrd Boulevard.

The above is the same property conveyed to the mortgagors herein by deed of Nanette Kellam Scoggins, Administratrix, recorded herewith in Deed Book 1189 at page 151.

The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
