To secure payment of a note which I signed today promising to pay you the above Total of Payments and to secure all my other and future obligations to you, the Maximum Outstanding at any given time not to exceed the amount stated above, each of the undersigned grants, bargains, sells and releases to you the real estate described below and all present and future improvements on the real estate, which is located in South Carolina, County of Greenville

All that piece, parcel or lot of land situate in the State of South Carolina, County of Greenville, on the northwestern side of Buckingham Road, being known and designated as Lot No. 225, as shown on a Plat of Gower Estates, Section B made by R. K. Campbell, Surveyor, December, 1961, and recorded in the R.M.C. Office for Greenville County, in Plat Book XX, at Pages 36 and 37, and having, according to said Plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the northwestern side of Buckingham Road, at the joint front corner of Lots 224 and 225, and runs thence with the line of Lot 224 N. 36-47 W. 189.3 feet to an iron pin; thence N. 60-51 E. 85 feet to an iron pin; thence with the line of Lot 226, S. 51-52 E. 176.3 feet to an iron pin on the northwestern side of Buckingham Road; thence with the curve of Buckingham Road, (the chord being S. 49-47 W. 130 feet) to the beginning corner. This conveyance is made subject to such easements, right-of-way and restrictions of record or as appear on the premises.

If I am in default for failure to make a required payment for 10 days or more, you may send me a notice giving me 20 days to eliminate the default. If I do not eliminate the default in the manner stated in the notice, or if I eliminate the default after you send the notice but default on a future payment by failing to pay on schedule, or if my ability to repay my loan or the condition, value or protection of your rights in the collateral securing my loan is significantly impaired, then the full amount I owe, less any charges which you have not yet earned, will become due, if you desire, without your advising me.

I will pay all expenses you incur in enforcing any security interest, including reasonable attorney's fees as permitted by law.

Each of the undersigned agrees that no extension of time or other variation of any obligation secured by this mortgage will affect any other obligations under this mortgage.

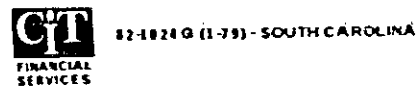
Each of the undersigned waives marital rights, homestead exemption and all other exemptions under South Carolina law.
