(herein "Lender").

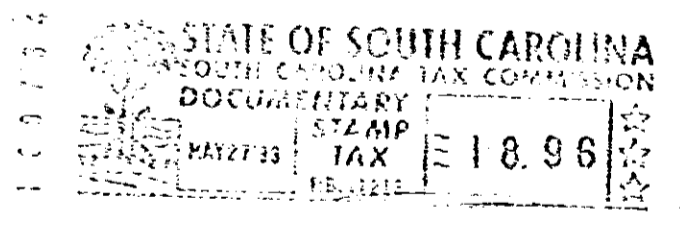
WHEREAS, Borrower is indebted to Lender in the principal sum of 47,400.00 Dollars,  
which indebtedness is evidenced by Borrower's Note date May 27, 1983 (herein "Note"),

repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21  
hereof (herein "Future Advances"), Borrower does hereby mortgage, grant, and convey to Lender and Lender's  
successors and assigns the following described property located in the County of Greenville,  
State of South Carolina:

ALL that piece, parcel or lot of land, lying and being situate in the  
County of Greenville, State of South Carolina, being shown and designated  
as Lot 3, Cardinal Drive, on a plat entitled "Survey for Kyle S. Bailey  
and Karen H. Bailey" as recorded in Plat Book 9-7 at Page 40, in  
the RMC Office for Greenville County, SC, and having according to said  
plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Cardinal Drive at the  
joint front corners of Lot 2 and Lot 3, said iron pin being 361.30 feet  
from the intersection of Cardinal Drive and Lee Road, running thence  
S. 25-58 E. 86.25 feet to an iron pin; thence S. 64-10 W. 139.18 feet  
to an iron pin; thence N. 25-57 W. 86.25 feet to an iron pin; thence  
N. 64-10 E. 139.15 feet to the point of beginning.
