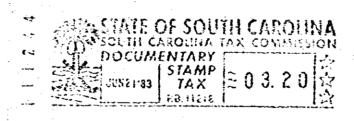

Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville....., State of South Carolina:

All that lot of land, situate, lying and being in Austin Township, County of Greenville, State of South Carolina, and being in the Town of Simpsonville, on the north side of South Pliney Circle, being shown and designated as Lot No. 50 in the subdivision known as League Estates, as shown on plat thereof dated October, 1941, prepared by W. J. Riddle, Surveyor, recorded in Plat Book K, at Pages 111 and 112, R. M. C. Office for Greenville County.

TO HAVE AND TO HOLD unto Lender and Lender's successors and assigns, forever, together with all the improvements now or hereafter erected on the property, and all easements, rights, appurtenances and rents, all of which shall be deemed to be and remain a part of the property covered by this Mortgage; and all of the foregoing, together with said property (or the leasehold estate if this Mortgage is on a leasehold) are hereinafter referred to as the "Property."

Borrower covenants that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, and that the Property is unencumbered, except for encumbrances of record. 2. Funds for Taxes and Insurance.
