THIS MORTGAGE is made this 30th day of June, 1983, between the Mortgagor, DAVID M. LOONEY AND ANN G. LOONEY, (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association of South Carolina, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

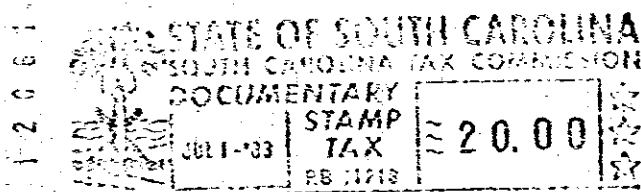
WHEREAS, Borrower is indebted to Lender in the principal sum of FIFTY THOUSAND AND NO/100 Dollars, which indebtedness is evidenced by Borrower's note dated June 30, 1983, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on July 1, 2013;

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina.

ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot No. 4, on Plat of Enoree Hills Subdivision recorded in the RMC Office for Greenville Co. in Plat Book MM at page 197 and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the northeasterly side of Berry Road at the joint front corner of Lots 3 and 4 and running thence along said Berry Road, N. 39-41 W., 113.1 feet to an iron pin at the intersection of Berry Road and Enoree Circle; thence with said Enoree Circle, N. 2-41 E., 57.0 feet to an iron pin at the joint front corner of Lots 4 and 5; thence S. 87-19 E., 200.0 feet to an iron pin; thence S. 22-42 E., 40.0 feet to an iron pin at the joint rear corner of Lots 3 and 4; thence S. 56-09 W., 175.5 feet to an iron pin on Berry Road, the point of beginning.
