## SCHEDULE "A"

## PARCEL A

All that parcel or tract of land in Butler Township of Greenville County, South Carolina, located about one mile northwest from Batesville, lying on the southwest side of Enoree River and on the east side of a community road, being a portion of Tract No. 5 on plat of the E. M. Dill property made by H. S. Brockman, Surveyor, dated November 20, 1945, amended April 22, 1960, and again on July 24, 1964, having the following courses and distances:

BEGINNING on an iron pin in the center of Community Road, joint front corner with other lands of Mary C. Masters and runs thence with line of Mary C. BEGINNING at a point in the center of Enoree River, said point being 125 feet in a northerly direction from the joint corner of Lot 4 and tract shown as 3.20 acres, more or less and running thence with the Enoree River as the line 510 feet, more or less to a point, the joint rear corner of Lots 3 and 4; thence with the common line of said lots N. 79-00 W. 1051 feet to a point in River Road; thence with the River Road N. 16-45 E. 340 feet to a point, the same being the corner of a new line on River Road; thence with this new line S. 89-25 E. 800 feet to the point of beginning.
