THIS MORTGAGE is made this 8th day of August 19 83, between the Mortgagor, Carol V. Perusse (herein "Borrower"), and the Mortgagee, Security Federal Savings and Loan Association of South Carolina, a corporation organized and existing under the laws of the United States, whose address is 1233 Washington Street, Columbia, South Carolina, 29201 (herein "Lender").
