

18 minutes East 78.6 feet to an iron pin; thence South 33 degrees 33 minutes East 141 feet to an iron pin on the North side of Alexander Street, the beginning corner, being the same property conveyed to Greenville Petroleum Company, Inc., by A. Parcel 3:
