"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, consisting of 3.82 acres, more or less, as shown on Plat prepared by C. O. Riddle, Surveyor, dated March, 1977, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on Brushy Creek Road and running thence along Brushy Creek Road N 63-29 W 150.3 feet to an iron pin; thence along the common line of property to be conveyed to Thelma H. Shaw N 18-52 E 999.1 feet to an iron pin on a County road; thence along said County road S 10-28 E 499 feet to an iron pin; thence S 28-08 W 591.8 feet to an iron pin being the point of beginning.
