WHEREAS, I, GEORGE LARRY WARD, JR.,

(hereinafter referred to as Mortgagor) is well and truly indebted unto Community Bank

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of SIX THOUSAND TWO HUNDRED SEVENTY-THREE AND 80/100-----  
Dollars (\$6,273.80) due and payable

in 60 monthly payments of \$156.36 each beginning November 1, 1983, payments applied first to interest, balance to principal, with right to anticipate payments in full or part without penalty,

with interest thereon from date at the rate of 16.77 APR per centum per annum, to be paid: monthly

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Tract No. 9 containing 0.9 Acres according to a survey of Groce Meadow Estates made by Jeffrey M. Plumblee, Surveyor, 4/27/83, and having according to said plat the following courses and distances, to wit:

BEGINNING at iron pin on Meadow Lane (private road) at the corner of Tracts 9 & 10 and running thence along Meadow Lane N. 60-22 E. 134.2 feet to iron pin at the joint front corner of Tracts 8 & 9; running thence along joint line of Tracts 8 & 9, S. 38-08 E. 321.5 feet to iron pin; running thence S. 62-43 W. 125 feet to iron pin, joint rear corner of Tracts 9 & 10; running thence along joint line of said tracts N. 39-56 W. 318 feet to point of beginning.
