MORTGAGE OF REAL ESTATE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, I, G. W. TYNER,

(hereinafter referred to as Mortgagor) is well and truly indebted unto NINA JAMES ISEMAN

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of **NINETEEN THOUSAND SEVEN HUNDRED FIFTY-FIVE AND NO/100** Dollars (\$ 19,755.00) due and payable in 66 monthly payments of \$400.00 per month and the 67th payment to be in the amount of \$24.18, first payment to be October 17, 1983,

with interest thereon from _____ date _____ at the rate of 11% per centum per annum, to be paid: **monthly**

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the western side of Lake Fairfield Drive near the City of Greenville, being known and designated as Lot No. 19 of a subdivision known as Lakeforest, Section 1, plat of which is recorded in the RMC Office for Greenville County in Plat Book GG, page 17 and having according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on Lake Fairfield Drive at the corner of Lot 20 and running thence along the line of Lot 20, S. 74-02 W. 183.1 feet to iron pin; thence S. 7-44 E. 100 feet to iron pin; thence N. 75-37 E. 205.8 feet to iron pin on Lake Fairfield Drive; thence along said drive N. 20-39 W. 105 feet to the point of beginning.

This being the same property conveyed to the Mortgagor herein by deed of the Mortgagee herein of even date herewith and recorded in the RMC Office for Greenville County simultaneously herewith.
