NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of

ALL that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, on the south side of Center Road, as shown on a plat of survey prepared by W. R. Williams, Jr., dated June 22, 1982, and recorded in the RMC Office for Greenville County in Plat Book 10-C, Page 27, and having the following metes and bounds, to-wit:

BEGINNING at a spike in the center of Center Road and running thence along the road S. 48-22 E. 205.1 feet to a nail and cap; thence S. 38-50 E. 80.0 feet to a nail and cap; thence S. 61-03 W. 318.6 feet to an iron pin; thence N. 43-40 W. 100.0 feet to an iron pin; thence N. 27-13 E. 315.2 feet to a spike in the road at the point of beginning, and containing 1.3 acres.

THIS conveyance is subject to all easements, restrictions, roadways, rights-of-way and other matters which may appear by examination of the public record or the premises herein.
