NOW KNOW ALL MEN That the Mortgagors, in order better to secure the payment of the note above mentioned in accordance with its terms, and all other sums mentioned therein or herein, to the Mortgagee, and also in consideration of the further sum of TEN DOLLARS to the Mortgagors in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real property: All that piece, parcel or lot of land in the State of South Carolina, County of Greenville, being known and designated as Lot No. 73 on a Plat of Subdivision known as Idlewild, which plat is recorded in the R.M.C. Office for Greenville County in Plat Book 4N at page 54 and having, according to said plat, such metes and bounds as appear thereon. Said lot fronts on the northern side of Crofton Drive a total distance of 79 feet.
