THIS MORTGAGE is made this 11th / 1st NOV. 1983 day of November 1983, between the Mortgagor, David L. Narramore

, (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association of South Carolina, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Eighty Five Thousand Six Hundred and No/100 (\$85,600.00) Dollars, which indebtedness is evidenced by Borrower's note dated October 11, 1983, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on October 11, 1984;

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of Greenville, State of South Carolina.

ALL that certain piece, parcel or lot of land situate, lying and being in Grove Township, Greenville County, South Carolina designated as Lot No. 26 on an addition to Section 2 of Belle Terre Acres, surveyed by James D. Crain, R.L.S., said plat being recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 4-X, at page 1, with the lot having the courses and distances shown on said plat.
