MORTGAGE

THIS MORTGAGE is made this 2nd day of November, 1983, between the Mortgagor, JAMES F. VAUGHN AND JOAN T. VAUGHN, (herein "Borrower"), and the Mortgagee, First Federal Savings and Loan Association of South Carolina, a corporation organized and existing under the laws of the United States of America, whose address is 301 College Street, Greenville, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Seventy-Five Thousand and No/100 (\$75,000.00) Dollars, which indebtedness is evidenced by Borrower's note dated November 2, 1983, (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on December 1, 2013;

TO SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of GREENVILLE, State of South Carolina.

ALL that piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, shown and designated as Lot No. 24, on a plat of Section II, Northwood, recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 9-F, at Page 79 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Bendingwood Circle and running thence with said street, S. 78-00 E. 70.0 feet to an iron pin, joint front corners of Lot Nos. 24 & 23, thence turning and running with the line of Lot No. 23, S. 0-52-54 E. 174.0 feet to a point, thence turning and running S. 81-30-38 W. 149.86 feet to a point; joint rear corners of Lots Nos. 24 & 25, thence turning and running with the line of Lot No. 25, N. 20-08-50 E. 224.39 feet to an iron pin, the point of beginning.
