NOW, THEREFORE, in consideration of the aforesaid loand and the sum of Three Dollars (\$3.00) cash in hand paid to Mortgagor, the receipt of which is hereby acknowledged. Mortgagor hereby grants, sells, conveys, assigns and releases to Mortgagee, its successors and assigns, the following described premises located in Greenville County, South Carolina:

ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the Northeastern corner of the interesection of Brentwood Way with Delmar Drive, in the Town of Simpsonville, being shown and designated as Lot No. 50 on a plat of Brentwood, Section 2 made by Piedmont Engineers and Architects dated May, 1972, recorded in the RMC Office for Greenville County, S.C. in Plat Book 4-R, page 5 and having according to said plat, the following metes and bounds, to-wit;
