- (1) That this mortgage shall secure the Mortgagee for such further states as may be advanced hereafter, at the option of the Mortgagee, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the convenants herein. This mortgagee shall also secure the Mortgagee for any further loans, whences, realizations or or altist that may be much be hereafter, to the Mortgager by the Mortgagee suching as the total indebtedness thus secured does not exceed the original amount shown on the face hereof. - (8) That the covenants herein contained shall bind, and the benefits and advantages shall insire to the respective heirs, executors, administrators, successors and assigns, of the parties hereto. Whenever used the singular shall include the plural, the plural the singular, and the use of any gender shall be applicable to all genders.
