Borrower covenants that he is lawfully seized of the premises herein above described in fee simple absolute estate, if any, as is stated hereinbefore), that he has good, right and lawful authority to sell, convey, mortgage or encumber the same, and that the premises are free and clear of all liens and encumbrances whatsoever except: (If none, so state.) 7. That, at the option of the Lender, this mortgage shall become due and payable forthwith if the Borrower shall convey away said mortgaged premises, or if the title shall become vested in any other person in any manner whatsoever other

than by the death of the Borrover.

8. That the Lender may, at its option, pay amounts due on any prior mortgage or other encumbrances and the same shall be added to the mortgage undebtedness and be secured by this mortgage and interest paid thereon as provided in Covenant

granted by vartue of the constitution and less of South Carolina or by wartue of any act of the United States Congress. Should any provision of this instrument be found to violate the laws or court decisions of the State of South Carolina or
