ALL that certain piece, parcel or lot of land, situate, lying and being in Greenville Township, County of Greenville, State of South Carolina, being known and designated as Lot No. 11 of Block N, Shaw Street (formerly First Street) of Park Place, as shown on plat of said property recorded in the RMC Office for Greenville County, S. C. in Plat Book A, at Page 119, and having, according to said plat, the following metes and bounds:

BEGINNING at a point at the North line of Shaw Street (formerly First Street), and at the Southwest corner of Lot No. 10, Block N, and running thence with the line of Shaw Street (formerly First Street), 73.5 feet to the intersection of line of Fourth Avenue of F. W. Poe Manufacturing Company Village; thence with line of D Street of F. W. Poe Manufacturing Company property, 149 feet to an alley; thence along South side of said alley, 51.9 feet to intersection with Northwest corner of Lot No. 10, 145 feet to the beginning corner of Park Place.
