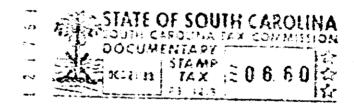

Mortgagor hereby grants, sells, conveys, assigns and releases to Mortgagee, its successors and assigns, the following described premises located in ____Greenville_____County, South Carolina:

ALL that lot of land in Greenville County, State of South Caroling, being shown as Lot No. 41 on plat of Dove Tree Subdivision, recorded in Plat Book 4X at Pages 21, 22 and 23 in the RMC Office for Greenville County.

This is the same property conveyed to the Mortgagors herein by Deed from Dove Tree Realty, A Partnership dated June 21, 1974 and recorded in the RMC Office for Greenville County in Deed Book 1101 at page 731 on June 25, 1974.



Together with all and singular the rights, members, hereditaments and appurtenances to said premises belonging or in anywise incident or appertaining. Including but not limited to all buildings, improvements, fixtures, or appurtenances now or hereafter erected thereon, including all apparatus, equipment, fixtures, or articles, whether in single units or centrally controlled, used to supply heat, gas, air conditioning, water, light, power, refrigeration, ventilation or other services, and also together with any screens, window shades, storm doors and windows, screen doors, awnings, stoves and water heater (all of which are declared to be a part of said real estate whether physically mitached thereto or not).

TO HAVE AND TO HOLD the same with all privileges and appurtenances thereunto belonging to Mortgagee, its successors and assigns, forever, for the purposes hereinafter set out and Mortgagor covenants with Mortgagee, its successors and assigns, that Mortgagor is seized of, and has the right to convey, the premises in fee simple; that the gremises are free and clear of all encumbrances except for a prior mortgage, if any; and that Mortgagor will warrant and defend title to the premises against the fawful claims of all persons whomsoever.

- TAXES Mortgagor will pay all taxes, assessments, water and sewer charges, and other governmental or ounicipal charges, fines, or impositions, for which provision has not been made hereinbefore, and will promptly eliver the official receipts thereof to the Mortgagee upon demand, and in default thereof the Mortgagee may pay the tame and add the amount of such payment(s) to the principal indebtedness due Mortgagee, and the same shall be repaid by Mortgagor with interest at the then prevailing note rate upon demand.
