with interest thereon from date at the rate of 16.5% per centum per annum, to be paid: per terms of note

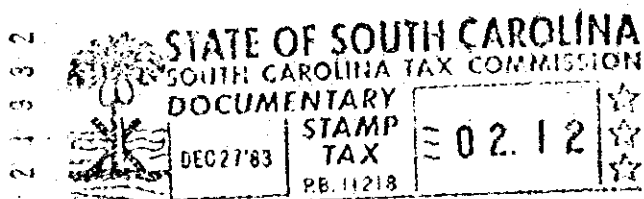

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Township, containing 0.67 acres, more or less, as shown on plat of Betty Lou and Michael D. Blackwell property recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 4-0, at Page 314, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin at the northwestern corner of the intersection of Layton Drive and S.C. Highway S23-102, at point "A", and running thence with the curve of Layton Drive, the traverse of which is N. 83-51 W. 374.5 feet to an iron pin; thence N. 46 W. 45.9 feet to an iron pin; thence N. 83-50 E. 404.1 feet to an iron pin on the western side of S.C. Highway S23-102; thence with the western side of said highway S. 1-45 E. 115.5 feet to the point of beginning.
