"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville

ALL that certain lot of land situate on the North side of Conway Drive, near the City of Greenville, in Greenville County, South Carolina, being shown as Lot No. 2 on plat of Pleasantburg Forest, made by Dalton & Neves, Engineers, August 1956, recorded in the RMC Office for Greenville County, SC in Plat Book GG, page 163, and having according to said plat the following metes and bounds, to-wit:
