(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Five Thousand and NO/100

Dollars (\$ 5,000.00 ) due and payable

180 days from the date hereof

with interest thereon from January 30, 1984 at the rate of fourteen (14) per centum per annum, to be paid: on or before July 29, 1984

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville

ALL that certain lot of land situate on the North side of Conway Drive, near the City of Greenville, in Greenville County, South Carolina, being shown as Lot No. 2 on plat of Pleasantburg Forest, made by Dalton & Neves, Engineers, August 1956, recorded in the RMC Office for Greenville County, SC in Plat Book GG, page 163, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the North side of Conway Drive, at the joint front corner of Lots 1 and 2, and running thence along the line of Lot 1, N. 29-15 W. 199.2 feet to an iron pin: thence N. 64-57 E. 110 feet to an iron pin; thence with the line of Lot 3, S. 20-31 E. 198.7 feet to an iron pin on the North side of Conway Drive; thence with the curve of Conway Drive, (the chord being S. 64-39 W. 80 feet) to the beginning corner.

THIS being the same property conveyed to the Mortgagor by deed of Julian A. and Helen B. Gault dated June 25, 1983 and recorded in the RMC Office for Greenville County in Deed Book 1191 at page 842.
