All that piece parcel or lot of land situate in the State of South Carolina, County of Greenville lying and being on the northern side of East Kenilworth Dr., being known and designated as Lot No. 48 as shown on Plat of Kingsgate, made by Piedmont Eng. and Architects and recorded in the NYC Office for Greenville County in plat book 144 at pages 44 and 45 and having according to said plat, the following dates and bounds, to-wit:

BEGINNING at an iron pin on the northern side of East Kenilworth Dr., at the joint front corner of Lots 47 and 49 and running thence along the common line of said lots N. 15-44 W. 265.9 Ft. to an iron pin; thence running S. 57-42 E. 124.7 Ft. to an iron pin at the joint rear corner of lots 48 and 49; thence with the common line of said lots S. 15-50 E. 223.7 Ft. to an iron pin on the northern side of East Kenilworth Dr., thence with the line of said dr. S. 22-39 W. 101.7 Ft. to an iron pin, thence continuing along said East Kenilworth Dr. S. 76-24 W. 18.4 Ft. to the point of beginning.

I will pay all expenses you incur in enforcing any security interest, including reasonable attorney's fees as permitted by law.

Each of the undersigned agrees that no extension of time or other variation of any obligation secured by this mortgage will affect any other obligations under this mortgage.

Each of the undersigned waives marital rights, homestead exemption and all other exemptions under South Carolina law.

This mortgage will extend, consolidate and renew any existing mortgage you hold against me on the real estate described above.
