Parcel 4

All those certain pieces, parcels or tracts of land lying, being and situate in the County of Greenville, South Carolina being shown as Parcel E, Parcel A, Parcel F and Parcel G as shown on a plat entitled "Survey for Carabo, Inc." prepared by Carolina Surveying Co., R. B. Bruce, R.L.S. dated June 21, 1983 and recorded in the R. M. C. Office for Greenville County, South Carolina in Plat Book 10A at Page 70 on December 23, 1983 and having according to said plat the following metes and bounds, to-wit:

PARCEL E

BEGINNING at an iron pin at the southwestern edge of the intersection of Bramlett Road and White Horse Road (U.S. 21 By-pass) and running thence S. 47-44 E., 150 feet to a spike along the right of way of White Horse Road; thence turning and running S. 54-21 W., 94.7 feet to a point; thence N. 47-44 W., 9.0 feet to a point; thence S. 45-44 W., 17.6 feet to a point; thence N. 42-42 W., 142.2 feet to a point; thence north to a point along the right of way of Bramlett Road (S.C. Hwy. 253); thence N. 50-20 E., 100 feet to an iron pin at the southwestern edge of the intersection of Bramlett Road and White Horse Road, the point of beginning, said tract containing 15,163 square feet, more or less.

PARCEL A

BEGINNING at an spike along the southwestern edge of the right of way of White Horse Road and running thence along the right of way of White Horse Road S. 47-44 E., 108.4 feet to a spike; thence S. 59-30 W., 60 feet to a point; thence N. 47-45 W., 108.3 feet to a point; thence N. 59-21 E., 60 feet to a spike along the southwestern edge of the right of way of White Horse Road, the point of beginning, said tract containing 6,212 square feet, more or less.

PARCEL F

BEGINNING at a point along the southern edge of the right of way of Bramlett Road (S.C. Hwy. 253) running thence S. 42-42 E., 142.2 feet to a point; thence N. 57-20 W., 155.6 feet to a point along the southern edge of the right of way of Bramlett Road; thence with the southern edge of Bramlett Road N. 59-20 E., 40.2 feet to a point along the southern edge of the right of way of Bramlett Road, the point of beginning, said tract containing 2,794 square feet, more or less.

PARCEL G

BEGINNING at an iron pin on the southern right of way line of Bramlett Road and running thence with the southern right of way of Bramlett Road N. 59-20 E., 59.7 feet to an iron pin along the northwestern corner of Parcel F; thence S. 57-20 E., 155.6 feet to a point; thence N. 45-44 E., 17.6 feet to a point; thence S. 47-44 E., 9.0 feet to a point; thence S. 66-29 W., 44.0 feet to an iron pin; thence S. 59-20 W., 20 feet to an iron pin; thence S. 51-50 W., 41.7 feet to an iron pin; thence N. 47-50 W., 150 feet to an old iron pin along the southern edge of the right of way of Bramlett Road, the point of beginning.
