NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, and in the City of Greenville, on the South Side of Gower Street, shown on a plat of property of W. O. Groce as made by Piedmont Engineering Service, A. C. Crouch, Engineer, in August of 1949, reference to which plat is hereby made; said property being described by metes and bounds, according to said plat, as follows, to-wit:

BEGINNING at an iron pin on the South side of Gower Street, at the intersection the Southern line of Gower Street with the Eastern line of a certain Twenty foot Alley, shown on said plat, and running thence South 28-30 West, along the Eastern line of said Alley, Four Hundred Thirteen and 8/10 feet to an iron pin on the Northern line of Rochester Alley Extension; thence along the Northern line of Rochester Alley Extension, South 62 East One Hundred Sixty-Five and 8/10 feet to an iron pin on the Western line of Groce Avenue as shown on said plat; thence along the Western line of Groce Avenue, North 28-30 East Four Hundred Eleven and 3/10 feet, more or less, to an iron pin on the South side of Gower Street; thence along the South side of Gower Street, North 60-37 West One Hundred Sixty-Three and 4/10 feet to the place of Beginning.
