THAT WHEREAS, Townes B. Johnson Company, Inc. is indebted to Mortgagee in the maximum principal sum of Fifteen Thousand Five Hundred and No/100 Dollars (\$15,500.00---), which indebtedness is evidenced by the Note of Townes B. Johnson Company, Inc. of even date herewith, said principal (plus interest thereon) being payable as provided for in said Note, (the final maturity of October 9, 1984, which is six months after the date hereof) the terms of said Note and any agreement modifying it are incorporated herein by reference.

NOW, THEREFORE, KNOW ALL MEN BY THESE PRESENTS that the said Mortgagor, for and in consideration of the aforesaid indebtedness and in order to secure the payment thereof together with any renewals or extensions or modifications thereof upon the same or different terms or at the same or different rate of interest and also to secure in accordance with Section 29-3-50, as amended, Code of Laws of South Carolina (1976): (i) all future advances and readvances that may subsequently be made to Mortgagor by Mortgagee evidenced by the aforesaid Note, or by other promissory notes, and all renewals and extensions thereof; and (ii) all other indebtedness of Mortgagor to Mortgagee, now or hereafter existing, whether direct or indirect, the maximum amount of all indebtedness outstanding at any one time secured hereby not to exceed \$15,500.00, plus interest thereon, all charges and expenses of collection incurred by Mortgagee including court costs and reasonable attorney's fees, has granted, bargained, sold, released and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described property:

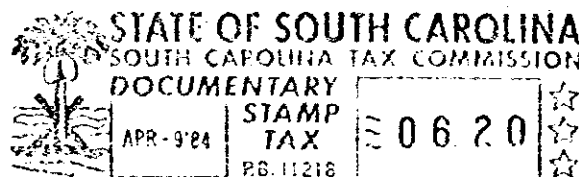

C. in Plat Book 8P, at Page 1, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the Northern side of Doverdale Road, at the joint front corner of Lots Nos. 116 and 117, and running thence with the joint line of said lots, N. 15-58 E. 150.00 feet to an iron pin in the line of Lot No. 118; thence with the line of Lot No. 118, S. 76-02 E. 90.00 feet to an iron pin at the joint rear corner of Lots Nos. 112, 113, 115, and 116; thence with the joint line of Lots Nos. 115 and 116, S. 15-58 W. 150.00 feet to an iron pin on the Northern side of Doverdale Road; thence with the Northern side of Doverdale Road, N. 76-02 W. 90.00 feet to the point of beginning.
