TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, Joe E. Casey and Annette R. Casey

(hereinafter referred to as Mortgagor) is well and truly indebted unto Sharonview Federal Credit Union,  
P. O. Box 32414, Charlotte, NC 28232,

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Ten Thousand Five Hundred and No/100-----  
----- Dollars (\$ 10,500.00 ) due and payable

according to the terms and provisions of the note of even date

with interest thereon from date at the rate of 11.5% per centum per annum, to be paid: semi-monthly.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the West side of Old Georgia Road, containing 1.11 acres, more or less, and according to a plat from a survey by John C. Smith bearing date of May 23, 1966, being more particularly described as follows, to-wit:

BEGINNING at a nail in the center of Old Georgia Road, running past an iron pin at the edge of said road, N. 60-30 W. 300 feet along line of L. J. Mears to an iron pin; thence, N. 25-57 E. 139.2 feet to an iron pin; thence due east with line of H. B. Rhodes 200 feet to and past an iron pin at the edge of road to a nail in the center of Old Georgia Road; thence with the center of Old Georgia Road, S. 0-10 W. 273 feet to the beginning corner.

This is the same property conveyed to the mortgagors herein by deed of H. B. Rhodes dated May 24, 1966, as recorded in the RMC Office for Greenville County, South Carolina, in Deed Book 802, at Page 138.

If all or any part of the property or an interest therein is sold or transferred by borrowers without lender's prior written consent, excluding: (a) The creation of a lien or encumbrance subordinate to this mortgage; (b) The creation of a purchase-money security interest for household appliances; (c) A transfer by devise, descent, or by operation of law upon the death of a joint tenant; or (d) The grant of any leasehold interest of three (3) years or less not containing an option to purchase, lender may, at lender's option, declare all the sums secured by the mortgage to be immediately due and payable.
