The Note contains provisions allowing for changes in the interest rate every year subject to the limits stated in the Note. If the interest rate increases, the Borrower's monthly payments will be higher. If the interest rate decreases, the Borrower's monthly payments will be lower.

ADDITIONAL COVENANTS. In addition to the covenants and agreements made in the Security Instrument, Borrower and Lender further covenant and agree as follows:

## A. INTEREST RATE AND MONTHLY PAYMENT CHANGES

The Note provides for an initial interest rate of 10.000%. Section 4 of the Note provides for changes in the interest rate and the monthly payments, as follows:

If the Index is no longer available, the Note Holder will choose a new index which is based upon comparable information. The Note Holder will give no notice of this choice.

The Original Index plus a margin of 2.500 % (after rounding the result up to the nearest 1/8 of 1%) is called the "Adjustment Base Pate."

(C) Calculation of Changes
