Words Used In This Document

- (A) Mortgage—This document, which is dated May 4, 19 84, will be called the "Mortgage".
- (B) Mortgagor—Ching Yuan Chao and Fu Hsim Chao will sometimes be called "Mortgagor" and sometimes simply "I", "Me", "my", "mine", "myself", and "us" refer to the Mortgagor.
- (C) Lender—The South Carolina National Bank will be called "Lender" and sometimes simply "you", "Your" and "yours" refer to Lender. Lender is a national banking association which was formed and which exists under the laws of the United States of America.

- (D) Note—The note, note agreement, or loan agreement signed by Ching Yuan Chao and Fu / and dated May 4, 1984, will be called the "Note". The Note shows that I have promised to pay Lender

which I have promised to pay in full by May 15, 1989

If this box is checked, finance charges or interest under the Note will be deferred, accrued, or capitalized.

- (E) Property—The property that is described below in the section entitled "Description Of The Property" will be called the "Property".

My Transfer To You Of Rights In The Property

On this date, because you loaned me the money for which I gave you the Note, I mortgage, grant and convey the Property to you, your successors and assigns, subject to the terms of this Mortgage. This means that by signing this Mortgage, I am giving you those rights that are stated in this Mortgage and also those rights that the law gives to lenders who hold mortgages on real property. I am giving you these rights to protect you from possible losses that might result if I fail to:

- (A) Pay all the amounts that I owe you as stated in the Note and any future advances made under Paragraph 17 of this Mortgage.
- (B) Pay, with interest or finance charges, any amounts that you spend under this Mortgage to protect the value of the Property and your rights in the Property.
- (C) Keep all of my other promises and agreements under the Note and/or this Mortgage.

This Mortgage secures any renewals, extensions, and/or modifications of the Note.

Description Of The Property

- (A) The Property which I mortgage, grant, and convey to you, your successors and assigns, is located in Greenville County and has the following legal description:

ALL that lot of land with building and improvements in the town of Mauldin, lying on the northwestern side of Miller Road in Austin Township, Greenville County, South Carolina, and shown on a plat of property of Clyde J. Jones by Carolina Surveying Company, dated August 18, 1982, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the northwestern side of Miller Road at the joint front corner of property of Clyde J. Jones and running thence along Miller Road S. 55-11 W., 108 feet to an iron pin at the intersection of Miller Road and Old Mill Road; thence along the northern side of Old Mill Road, N. 65-32 W., 155 feet to an iron pin; thence N. 21-50 E., 251.8 feet to an iron pin, joint rear corner of other property of Clyde J. Jones; thence S. 29-57 E., 272.6 feet to an iron pin on the northwestern side of Miller Road, the point of beginning.

This is the same property conveyed to the Mortgagor herein by deed of Clyde J. Jones dated September 27, 1982, and recorded in the R.M.C. Office for Greenville County in Deed Book 1174 at Page 779.

- (B) All buildings and other improvements that are located on the property described in paragraph (A) of this section;
- (C) All rights in other property I have as owner of the property described in paragraph (A) of this section. These rights are known as "easements, rights and appurtenances attached to the property";
- (D) All rents or royalties from the property described in paragraph (A) of this section;
- (E) All mineral, oil and gas rights and profits, water, water rights and water stock that are part of the property described in paragraph (A) of this section;
- (F) All rights that I have in the land which lies in the streets or roads in front of, or next to, the property described in paragraph (A) of this section;
- (G) All fixtures that are now or in the future will be on the property described in paragraphs (A) and (B) of this section, and, to the extent allowed by law, all replacements of and additions to those fixtures;
- (H) All of the rights and property described in paragraphs (B) through (F) of this section that I acquire in the future; and
- (I) All replacements of and/or additions to the property described in paragraphs (B) through (F) and paragraph (H) of this section.

You, your successors and assigns, are to have and to hold the Property, subject to the terms of this Mortgage.
