(\$3,771.85) Dollars to be paid in Eighty-Four (84) equal installments in the sum of Seventy-Two and 90/100 (\$72.90) Dollars each, beginning June 8, 1984, and a like installment being due and payable on the 8th day of each and every calendar month thereafter until paid in full.

with interest thereon from date at the rate of Business prime plus three (3%) percent monthly
