BEGINNING at an iron pin on the southwestern side of Evergreen Street (formerly Douglas Avenue) at the joint front corner of Lots 75 and 76 and running thence with the joint line of said lots S. 46-03 W., 337.9 feet to edge of a 12 foot alley; thence with the line of said alley S. 41-45 E., 60 feet to an iron pin at the corner of Lot 74; thence with the line of Lot 74 N. 46-03 E., 340.2 feet to an iron pin on the southwestern side of Evergreen Street; thence with the southwestern side of said street N. 44-02 E., 60 feet to the beginning corner.

4. That if default be made in the performance of any of the terms hereof, or if any of said rental or other sums be not paid to Bank when due, Bank, at its election, may declare the entire remaining unpaid principal and interest of any obligation or indebted-

ness then remaining unpaid to Bank to be due and payable forthwith. 5. That Bank may and is hereby authorized and permitted to cause this instrument to be recorded at such time and in such places

6. Upon payment of all indebtedness of the undersigned to Bank this agreement shall be and become void and of no effect, and as Bank, in its discretion, may elect. until then it shall apply to and bind the undersigned, their heirs, legatees, devisees, administrators, executors, successors and assigns, and inure to the benefit of Bank and its successors and assigns. The affidavit of any officer or department manager of Bank assigns, and inure to the benefit of Bank and its successors and assigns. showing any part of said indebtedness to remain unpaid shall be and constitute conclusive evidence of the validity, effectiveness and continuing force of this agreement and any person may and is hereby authorized to rely thereon.
