To secure payment of a note which I signed today promising to pay you the above Total of Payments and to secure all my other and future obligations to you, the Maximum Outstanding of any given time not to exceed the amount stated above, each of the undersigned grants, conveys, sells and releases to you the real estate described below and all present and future improvements on the real estate, which is located in South Carolina, County of GREENVILLE

All that lot of land in Greenville County, State of South Carolina, lying and on the southeast side of East 7th Street in Woodside Village near the City of Greenville, being shown as Lot #52, Section C, on plat of Woodside Mills Subdivision prepared by Pickell & Pickell dated January 14, 1950, recorded in Plat Book W at pages 111-117, and according to said plat being more particularly described as follows:

Beginning at an iron pin on the southeast side of East 7th Street joint front corner of Lots 52 and 53, which pin is 57.1 feet southeast of the intersection of said street with an unnamed street; thence with the line of lot 53, S 7-29 E 102 feet to an iron pin on the northwest side of a 12-foot alley; thence with said alley, S 82-31 W 58 feet to an iron pin at corner of Lot 5; thence with line of said lot, N 7-29 W 102 feet to an iron pin on the southeast side of East 7th Street, thence with the southeast side of said street, N 52-31 E 58 feet to the beginning corner.
