THIS MORTGAGE is made this 25 day of JUNE 19 84, between the Mortgagor, KENT HOWARD KISTLER AND PRISCILLA S. KISTLER (herein "Borrower"), and the Mortgagee, AMERICAN FEDERAL BANK, FSB, a corporation organized and existing under the laws of THE UNITED STATES OF AMERICA, whose address is 101 EAST WASHINGTON STREET, GREENVILLE, SOUTH CAROLINA (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of NINETY-EIGHT THOUSAND EIGHT HUNDRED (\$98,800.00) Dollars, which indebtedness is evidenced by Borrower's note dated JUNE 25, 1984 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on JULY 1, 2014

To SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of GREENVILLE, State of South Carolina:

ALL that certain piece, parcel or lot of land with all improvements thereon, situate, lying and being on the Eastern side of ISBELL LANE in the City of Greenville, County of Greenville, State of South Carolina, and being shown and designated as LOT 10, ISBELL HEIGHTS, on a plat thereof made by Piedmont Engineers and Architects, dated AUGUST 21, 1963, and recorded in the RMC Office for Greenville County in Plat Book XX at Page 167, reference being had to said plat for a more complete metes and bounds description.

THIS being the same property acquired by the Mortgagors by deed of DAVID L. LINDSEY and NITA W. LINDSEY dated June 25, 1984, to be recorded herewith.
