(A) Mortgage—This document, which is dated July 6, 1984 will be called the "Mortgage".

(B) Mortgagor—DOROTHY M. LOFTIS will sometimes be called "Mortgagor" and sometimes simply "I", "Me", "my", "mine", "myself", and "us" refer to the Mortgagor.

(C) Lender—The South Carolina National Bank will be called "Lender" and sometimes simply "you". "Your" and "yours" refer to Lender. Lender is a national banking association which was formed and which exists under the laws of the United States of America.

Lender's address is Post Office Box 969, Greenville, SC 29602

(D) Note—The note, note agreement, or loan agreement signed by Dorothy M. Loftis, Jimmy R. Loftis and Linda D. Loftis dated July 6, 1984 will be called the "Note". The Note shows that I have promised to pay Lender

11,160.00 Dollars plus finance charges or interest at the rate of 15.50 % per year

which I have promised to pay in full by July 20, 1994

If this box is checked, finance charges or interest under the Note will be deferred, accrued, or capitalized.

(E) Property—The property that is described below in the section entitled "Description Of The Property" will be called the "Property".

#### My Transfer To You Of Rights In The Property

On this date, because you loaned me the money for which I gave you the Note, I mortgage, grant and convey the Property to you, your successors and assigns, subject to the terms of this Mortgage. This means that by signing this Mortgage, I am giving you those rights that are stated in this Mortgage and also those rights that the law gives to lenders who hold mortgages on real property. I am giving you these rights to protect you from possible losses that might result if I fail to:

(A) Pay all the amounts that I owe you as stated in the Note and any future advances made under Paragraph 17 of this Mortgage.

(B) Pay, with interest or finance charges, any amounts that you spend under this Mortgage to protect the value of the Property and your rights in the Property.

(C) Keep all of my other promises and agreements under the Note and/or this Mortgage.

This Mortgage secures any renewals, extensions, and/or modifications of the Note.

#### Description Of The Property

(A) The Property which I mortgage, grant, and convey to you, your successors and assigns, is located in Greenville County and has the following legal description:

ALL that piece, parcel or lot of land, with the buildings and improvements thereon, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot 112 on plat of Chestnut Hills, which plat is recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book GG at pages 64 and 65, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southerly side of Westbrook Drive, joint front corner of Lots 111 and 112, the said iron pin being 170 feet in a westerly direction from the intersection of Westbrook Drive and Chipley Lane; and running thence S. 15-08 W. 185.5 feet to an iron pin; thence S. 78-18 E. 75.13 feet to an iron pin; thence N. 5-08 E. 181 feet to an iron pin on Westbrook Drive, joint corner of Lot 113; thence along Westbrook Drive N. 74-52 W. 75 feet to an iron pin, the point of beginning.

This is the same property conveyed to the mortgagor herein by deed of Willard Page and Carol K. Page recorded September 3, 1969, in Deed Book 875 at page 133 in the R.M.C. Office for Greenville County.

The Property also includes the following:

- (B) All buildings and other improvements that are located on the property described in paragraph (A) of this section;
- (C) All rights in other property I have as owner of the property described in paragraph (A) of this section. These rights are known as "easements, rights and appurtenances attached to the property";
- (D) All rents or royalties from the property described in paragraph (A) of this section;
- (E) All mineral, oil and gas rights and profits, water, water rights and water stock that are part of the property described in paragraph (A) of this section;
- (F) All rights that I have in the land which lies in the streets or roads in front of, or next to, the property described in paragraph (A) of this section;
- (G) All fixtures that are now or in the future will be on the property described in paragraphs (A) and (B) of this section, and, to the extent allowed by law, all replacements of and additions to those fixtures;
- (H) All of the rights and property described in paragraphs (B) through (F) of this section that I acquire in the future; and
- (I) All replacements of and/or additions to the property described in paragraphs (B) through (F) and paragraph (H) of this section.

You, your successors and assigns, are to have and to hold the Property, subject to the terms of this Mortgage.
