To secure payment of a note which I signed today promising to pay you the above Total of Payments and to secure all my other and future obligations to you, the Maximum Outstanding at any given time not to exceed the amount stated above, each of the undersigned grants, bargains, sells and releases to you the real estate described below and all present and future improvements on the real estate, which is located in South Carolina, County of Greenville

All that lot of land lying in the County of Greenville, State of South Carolina, being known and designated as Lot No. 1 on a plat of Fore Estates Subdivision, recorded in Plat Book BB, at page 61, in the RMC Office for Greenville County, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on Staunton Bridge Road, joint front corner of Lots 1 and 2; and running thence along the line of said Lots, N 69-20 W, 199.9 feet to an iron pin; thence with the line of Lot No. 32, N. 20-40 E. 85.8 feet to an iron pin; thence S. 67-33 E. 200.1 feet to an iron pin on Staunton Bridge Road; thence with said Road, S. 20-47 W. 80 feet to the point of beginning.

I will pay all expenses you incur in enforcing any security interest, including reasonable attorney's fees as permitted by law.

Each of the undersigned agrees that no extension of time or other variation of any obligation secured by this mortgage will affect any other obligations under this mortgage.

Each of the undersigned waives marital rights, homestead exemption and all other exemptions under South Carolina law.
