S., dated August, 1981, and recorded in the RMC Office for Greenville County, South Carolina in Book 8-U at Page 67, and having the following courses and distances: Beginning at a point on Gillam Road on the Northeastern side of the tract herein conveyed; thence South Twenty (20) degrees Fourteen (14) minutes West for a distance of Two Hundred Twenty-nine and ninety three/100 (229.93) feet to an iron pin; thence South Seventy eight (78) degrees Twenty Four (24) minutes West for a distance of One Hundred Fifty-two and forty two/100 (152.42) feet to an iron pin; thence North IN THE EVENT, that this loan transaction relates to the financing of real estate together with a mobile home located thereon as evidenced by the application and/or other loan documents, the following specific additional description shall be applicable:

Together with all and singular rights, members, herditaments, and oppurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise to be had thereform, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered as a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever. The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumbe, the same, and that the premises are free and clear of all liens and encumbrances except as provided herein.
