"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE.

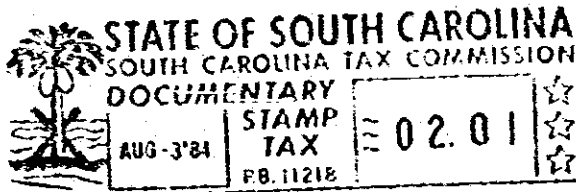
ALL that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, approximately 13 miles north of Travelers Rest, containing 1.03 acres, more or less, and according to plat of Survey prepared by T. Craig Keith, Reg. L.S. No. 1712, dated March 18, 1982, having the following metes and bounds, to-wit:

BEGINNING at a RR spike in center of Beaver Dam Road and running thence N.49-05 E. 290 feet to a RR spike in center of said road; thence along line of other Gosnell property, S.41-39 E. 161.9 feet to a corner IP; thence along line of Jack Overpeck property, S.51-20 W. 285 feet to a corner IP; thence along line of other Gosnell property, N.43-41 W. 150.9 feet to RR spike on center line of said Beaver Dam Road, the point of beginning.
