with interest thereon from January 1, 1985 at the rate of 12 3/4 per centum per annum, to be paid: monthly

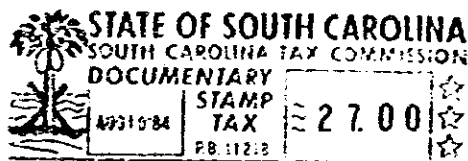

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Mauldin, and being on the southwestern side of Winchester Court and being shown and designated as Lot No. 3 on a Plat of OAKTREE PLAZA made by Enwright Associates dated June 24, 1974 and recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 4R, Page 70, reference to which is hereby craved for the metes and bounds thereof.

The above described property is the same property conveyed to the Mortgagor herein by deed of Esca E. Alkema dated July 12, 1984, to be recorded herewith.
