per centum per annum, to be paid as provided in said note; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

ALL that certain piece, parcel or lot of land, together with all buildings and improvements thereon, situate, lying and being on the eastern side of Vesper Circle, Town of Mauldin, County of Greenville, State of South Carolina, being known and designated as Lot No. 64, on plat entitled SUNSET HEIGHTS SECTION 2, prepared by Dalton & Neves, dated April, 1960, and recorded in the RMC Office for Greenville County, S.C. in Plat Book RR, at Page 85, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the easterly side of Vesper Circle at the joint front corners of Lots Nos. 44 and 64; running thence with the common line of said lots, S. 69-44 E., 199.6 feet to an iron pin; thence along the common line of Lots Nos. 62 and 64, S. 45-25 W., 147.9 feet to an iron pin; thence along the common line of Lots Nos. 63 and 64, N. 77-08 W., 122.8 feet to an iron pin on the easterly side of Vesper Circle; thence along the easterly side of Vesper Circle, N. 14-38 E., 150 feet to an iron pin; the point of beginning.

This is the identical property conveyed to the Mortgagors herein by deed of WILLIAM J. MILLER and PATRICIA A. MILLER, dated August 30, 1984 and recorded in the RMC Office for Greenville County, S.C. in Deed Book 1220, at Page 973, on August 4, 1984.

Together with all and singular rights, members, herditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor further covenants and agrees as follows:

(1) That this mortgage shall secure the Mortgagee for such further sums as may be advanced hereafter, at the option of the Mortgagee, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the covenants herein.
