4. INTEREST RATE AND HONTHLY PAYMENT CHANGES

(A) Change Dates that day every 12th month thereafter. Each date on which my interest rate could change is called a "Change Date."

Beginning with the first Change Date, my interest rate will be based on an Index. The "Index" is the weekly average yield on United States Treasury securities adjusted to a constant maturity of 1 year, as made available

If the Index is no longer available, the Note Holder will choose a new index which is based upon comparable information. The Note Bolder will give me notice of this choice.

(C) Calculation of Changes will then round the result of this addition to the searest one-eighth of one percentage point (0.125%). Subject to the limits stated in Section 4(D) below, this rounded amount will be my new interest rate until the next Change Date.

The Note Holder will then determine the amount of the monthly payment that would be sufficient to repay the unpaid principal that I am expected to owe at the Change Date in full on the maturity date at my new interest rate in substantially equal payments. The result of this calculation will be the new amount of my monthly payment.

(D) Limits on Interest Rate Changes

The rate of interest I am required to pay shall never be increased or decreased on any single Change Date by more than percentage points (.....) from the rate of interest I have been paying for the preceding twelve months. (E) Effective Date of Changes
