"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of

ALL that certain piece, parcel, or lot of land, situate, lying and being near the Town of Mauldin, Greenville County, South Carolina, being shown and designated as Lot 91 on Revised Plats Nos. 1 and 2 of VERDIN ESTATES Subdivision, recorded in the RMC Office for Greenville County in Plat Book 6-H, at Pages 47 and 48. 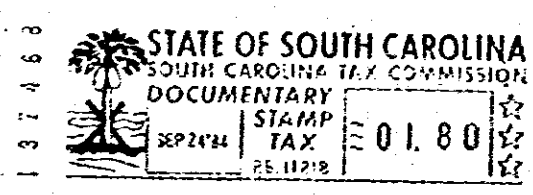
