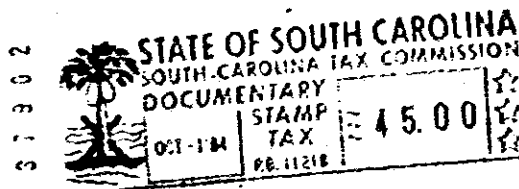
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, the Mortgagee's heirs, successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE.

ALL that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, on the northwestern side of Wade Hampton Boulevard (U.S. Highway No. 29) and being shown and designated on plat entitled "Property of Rimer, Inc.", recorded in the RMC Office for Greenville County in Plat Book ZZ at Page 11 and being shown on a more recent plat entitled "Property of Kenneth W. Gurley", prepared by Carolina Surveying Company, dated August 26, 1982, and recorded in the RMC Office for Greenville County in Plat Book 9-G at Page 73, and having such metes and bounds as shown on the more recent plat, reference to which is hereby made for a more complete description.
