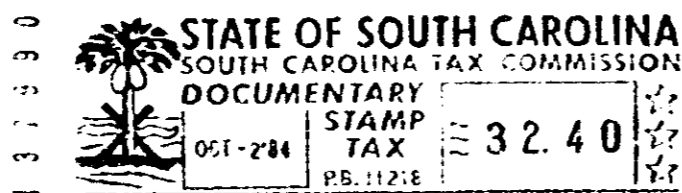

## MORTGAGE

THIS MORTGAGE ("Security Instrument") is given on OCTOBER 1, 1984. The mortgagor is DANIEL R. MCGEE AND BARBARA K. MCGEE ("Borrower"). This Security Instrument is given to ALLIANCE MORTGAGE COMPANY, which is organized and existing under the laws of THE STATE OF FLORIDA, and whose address is POST OFFICE BOX 2139, JACKSONVILLE, FLORIDA 32232 ("Lender"). Borrower owes Lender the principal sum of ONE HUNDRED EIGHT THOUSAND AND NO/100THS Dollars (U.S. \$ 108,000.00). This debt is evidenced by Borrower's note dated the same date as this Security Instrument ("Note"), which provides for monthly payments, with the full debt, if not paid earlier, due and payable on OCTOBER 1, 2014. This Security Instrument secures to Lender: (a) the repayment of the debt evidenced by the Note, with interest, and all renewals, extensions and modifications; (b) the payment of all other sums, with interest, advanced under paragraph 7 to protect the security of this Security Instrument; and (c) the performance of Borrower's covenants and agreements under this Security Instrument and the Note. For this purpose, Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in GREENVILLE County, South Carolina:

ALL that certain piece, parcel or lot of land with all improvements thereon, situate, lying and being on the Western side of CHISOLM TRAIL in the City of Greenville, County of Greenville, State of South Carolina, and being shown and designated as LOT 40, SECTION II, PARKINS LAKE DEVELOPMENT, on a plat made by R. K. Campbell, dated October 22, 1962, and recorded in the RMC Office for Greenville County in Plat Book YY at Page 93, reference being had to said plat for a more complete metes and bounds description.

THE above described property is the same acquired by the Mortgagors by deed of Paula Sue Smith (formerly Paula Sue Lassen) dated October 1, 1984, to be recorded herewith.

TO HAVE AND TO HOLD such property unto Lender and Lender's successors and assigns, forever, together with all the improvements now or hereafter erected on the property, and all easements, rights, appurtenances, rents, royalties, mineral, oil and gas rights and profits, water rights and stock and all fixtures now or hereafter a part of the property. All replacements and additions shall also be covered by this Security Instrument. All of the foregoing is referred to in this Security Instrument as the "Property."

BORROWER COVENANTS that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property and that the Property is unencumbered, except for encumbrances of record. Borrower warrants and will defend generally the title to the Property against all claims and demands, subject to any encumbrances of record.

THIS SECURITY INSTRUMENT combines uniform covenants for national use and non-uniform covenants with limited variations by jurisdiction to constitute a uniform security instrument covering real property.
