THIS AGREEMENT made this 10-01 day of October, 1984, between Security Federal Savings and Loan Association of South Carolina, hereinafter referred to as "Party of the First Part," and Design I Enterprises, Inc., hereinafter referred to as "Party of the Second Part"; and Donna P.H.C.

WHEREAS, the Party of the First Part is the owner and holder of a certain note and mortgage heretofore executed by Party of the Second Part to it dated January 11, 1984, said mortgage being recorded in the office of the Register of Mesne Conveyance for Greenville County, South Carolina, in Mortgage Book 1643 at page 633, securing the payment of a note in the amount of Ninety-five thousand Six hundred and no/100 (\$ 95,600.00) Dollars, with interest thereon at the rate of Thirteen (13.00 %) percent per annum, which note and mortgage are hereby incorporated as a part of this instrument; and

WHEREAS, the undersigned Party of the Second Part has requested a modification of the terms of said note and mortgage whereby the time for payment of said indebtedness as set out in said note shall be extended for a period of Three months; and

WHEREAS, the Party of the First Part has agreed to said extension on the condition that the interest rate provided in said note, secured by said mortgage, shall be increased from N/A (%) percent per annum to N/A (%) percent per annum, effective as of , 198 ; and

WHEREAS, the Party of the Second Part has agreed to said increase in the interest rate.

NOW, THEREFORE, in consideration of the premises and other good and valuable consideration, receipt of which is hereby acknowledged, the parties hereto and their heirs, executors, administrators, successors and assigns, mutually agree as follows:

1. That the time for payment of the indebtedness as set out in the above referred to note, and the mortgage given to secure the same, which are incorporated herein by reference thereto, shall be extended for a period of three months. This extension will mature December 28, 1984.

2. That the interest rate provided for in said note shall be increased from N/A (%) percent per annum to (%) percent per annum, effective as of , 198 ; that the time for payment of interest, as provided for in said note, shall remain the same.

3. That except as modified and extended hereby, all other provisions of the mortgage, and the note secured thereby, shall remain in full force and effect.

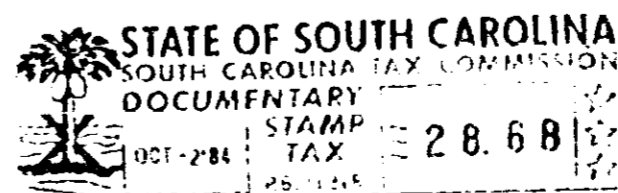
