ALL that piece, parcel or lot of land, with all buildings and improvements thereon, situate, lying and being on the northeastern corner of the intersection of Rosewood Drive with Old Mill Road, in Greenville County, South Carolina, being shown and designated as Lot No. 57 on a plat of EDWARDS FOREST HEIGHTS, made by Jones Engineering Service, dated February 1967, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 000 at Page 89, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Rosewood Drive at the joint corner of Lots Nos. 57 and 58 and running thence with the common line of said lots, S. 88-41, W., 130 feet to an iron pin; thenc along the common line of Lots Nos. 64 and 57, S. 17-52 W., 131 feet to an iron pin on the northern side of Old Mill Road; thence along the northern side of Old Mill Road, S. 74-58 E., 150 feet to an iron pin; thence along the curve of the intersection of Old Mill Road and Rosewood Drive, the chord of which is N. 51-47 E., 35.9 feet to an iron pin on he western side of Rosewood Drive; thence along the western side of Rosewood Drive, N. 1-29 W., 144.5 feet to an iron pin, the point of beginning.
