MORTGAGE OF REAL ESTATE

To secure payment of a note which I signed today promising to pay you the above Amount Financed together with a finance charge and to secure all my other and future obligations to you, the Maximum Outstanding at any given time not to exceed the amount stated above, each of the undersigned grants, bargains, sells and releases to you the real estate described below and all present and future improvements on the real estate, which is located in South Carolina, County of Greenville.

All that piece, parcel or lot of land, situate, lying and being in the State of South Carolina County of Greenville, on the southern side of Rosewood Drive, being shown and designated as Lot No. 72 on plat of PINE BRICK FOREST, recorded in the REC Office for Greenville County in Plat Book 4-K at Pages 48 and 49, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Rosewood Drive, joint front corner of Lots Nos. 71 and 72, and running thence along the common line of said lots, S. 16-35 E. 150 feet to an iron pin; thence running S. 73-25 W. 125 feet to an iron pin, joint rear corner of Lots Nos. 72 and 73; thence running along the common line of said lots, N. 16-35 W. 150 feet to and iron pin on the southern side of Rosewood Drive; thence along the southern side of Rosewood Drive N. 73-25 E. 125 feet to an iron pin; the point of beginning. PAYMENT OF OBLIGATIONS
If I pay the note secured by this mortgage according to its terms this mortgage will become null and void.

TAXES - LIENS - INSURANCE

I will pay all taxes, liens, assessments, obligations, encumbrances and any other charges against the real estate, whether superior or inferior to the lien of this mortgage, and maintain insurance on the real estate in your favor in a form and amount satisfactory to you. DEFAULT

If I do not eliminate the default in the manner stated in the notice, or if I eliminate the default after you send the notice but default on a future payment by failing to pay on schedule, or if my ability to repay my loan or the condition, value or protection of your rights in the collateral securing my loan is significantly impaired, then the entire unpaid amount financed and accrued and unpaid finance charge, will become due, if you desire, without your advising me.

I will pay all expenses you incur in enforcing any security interest, including reasonable attorney's fees as permitted by law.

EXTENSIONS AND MODIFICATIONS

Each of the undersigned agrees that no extension of time or other variation of any obligation secured by this mortgage will affect any other obligations under this mortgage.

WAIVER OF EXEMPTIONS

Each of the undersigned waives marital rights, homestead exemption and all other exemptions under South Carolina law.
