"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE.

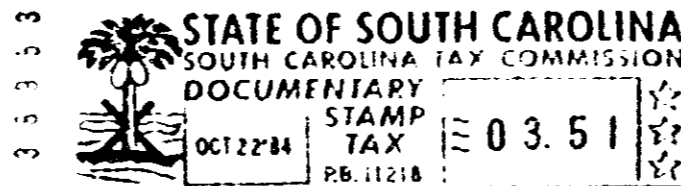
ALL that certain piece, parcel or tract of land situate, lying and being in the County of Greenville, State of South Carolina, on the northwestern side of S. C. Highway No. 414 and being shown as Tract No. 3, containing 5.2 acres, on a plat entitled "Survey for Clarence V. Glenn and Roy A. Lockaby", prepared by Jeffery M. Plumblee, Inc., dated September 25, 1984, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a new iron pin on the northwestern side of S. C. Highway No. 414, joint front corner of Tracts 2 and 3 and running thence along the common line of said tracts, N.20-56 W. 753.9 feet to an iron pin; thence turning and running N.57-26 E. 298.1 feet to an iron pin; thence turning and running S.21-44 E. 775.5 feet to an iron pin on the northwestern side of S. C. Highway No. 414; thence running along the northwestern side of S. C. Highway No. 414, S.63-11 W. 104.6 feet to an iron pin; S.62-09 W. 121.1 feet to an iron pin; and S.59-30 W. 80.0 feet to the point of beginning.
