

**18. BORROWER'S MAINTENANCE OF PROPERTY**

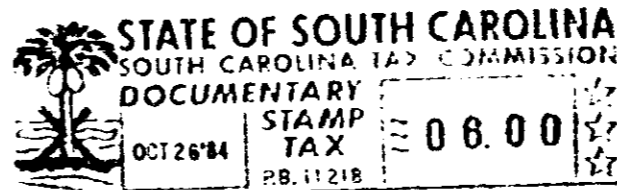
