and bounds description thereof.

This conveyance is made subject to all restrictions, easements and rights of way
which may affect the property hereinabove described.

Derivation Clause: This being the same property conveyed to the mortgagor herein

Together with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging, or in
anywise incident or appertaining

TO HAVE AND TO HOLD said premises unto said Mortgagee Blazer Financial Services, Inc. and assigns
of South Carolina forever, hereby binding our heirs, executors, and administrators, to warrant and forever defend all and singular the said premises
unto the Mortgagee.
